#### Project Description:

The Department has made a tentative determination to approve an application for a new permit for a proposed withdrawal and discharge of up to 576,000 gallons per day of treated groundwater into the East River (Class I) via NYCDEP Outfall BB-033 from a treatment system consisting of a 400-gpm treatment process with 21,000 gallon settling tank, two bag filter housings, and two 9,000 pound carbon units at the applicant's project site located at 1-02 26th Avenue, Queens (Block 915, Lot 6) where the applicant will temporarily dewater to facilitate construction of a new multi-story building and various utilities.

#### Availability of Application Documents:

Filed application documents, and Department draft permits where applicable, are available for inspection during normal business hours at the address of the contact person. To ensure timely service at the time of inspection, it is recommended that an appointment be made with the contact person.

This project is subject to the Department's Environmental Justice Policy and an enhanced public participation plan has been prepared and accepted as a component of application completeness.
